



Meeting our clients

Our initial contact with clients is often through phone calls or email inquiries. Upon receipt of inquiries from clients, we schedule an initial consultation with the client, either in-person or online wherein we endeavour to understand our client's needs by getting to know the client more and discussing the details of their legal concerns.

During this meeting, we provide an opportunity for the client to voice all their concerns and expectations. We then provide an overview of the key legal issues discussed and guide the client on the next steps. Where the client is comfortable proceeding with us, they give us instructions to represent them in their matter.



Creating a client profile

Once a client asks us to represent them, we create a Client Profile for them. This Client Profile is confidential and is tailored to the client's details, legal requirements and goals, important dates and timelines, and communication style information.

This Profile is securely built and stored in our internally developed enterprise software. The purpose of the profile is to ensure there is accuracy and consistency when handling the client's matters. It also ensures that we are up to date on all the client's matters before us.



Providing a perfectly tailored service

Upon creation of the Client Profile, we then begin to assess the legal issues presented to us by our client in-depth and begin our action as the client's legal representatives. We develop a tailored legal strategy based on the client's needs and follow through on the matter to the end.
